

ANNUAL REPORT ON CSR ACTIVITIES (FY 2021-22)

1. A brief outline of the CSR policy of the Company:

 - o Training to promote rural sports, nationally recognised sports and paralympic sports
- (v) **Contribution and Financial Assistance:**
 - o Contribution to Prime Minister's National Relief Fund or any other fund set up by the Central Government for socio- economic development and relief and welfare of the Scheduled Castes, the Scheduled Tribes, other backward classes, minorities and women.
